The registration fee includes the expenses for conference organization and issue, as well as, the fee of auditorium, accommodation and board costs as a transferred service.

The personal income-tax and EHO after the meal expenses will be paid by the Hungarian Corrosion Society.

Please return the registration form a.s.a.p., but not later than 27th July, 2015. The organizing committee is going to send the invoice for transfer of registration up-on your registration form.

Conference accommodation and board can be provided only after the payment of participation fee has been checked upon arrival or in case of booked application the fees to be paid in place.

A cancellation of the participation is possible 30 days before the event. Without advance notification the cancellation fee is 35 000 HUF + 27% VAT (115 EUR + VAT).
